I am by direction of the Vice-Chancellor to inform you that the Doctoral Committee is constituted for your Ph.D. scholar Ms.Sathiyavani V as required under our Ph.D. Regulations

- (1) I wish to inform that the same Committee should continue for the scholar to monitor the progress of the scholar effectively till the scholar completes his/her Research.
- (2) In the first Doctoral Committee Meeting.
 - (a) the Broad area of Research should be decided
 - (b) the course work should be prescribed as below
 - Paper I Research and Publication Ethics (RPE) mandatory paper as pre UGC Regulations, Common Syllabus
 - Paper II -- Research Methodology (Common Syllabus) (ii)
 - (iii) Paper - III - Subject Oriented (Common to the Department or a paper may be prescribed)
 - (iv) Paper - IV Related to the Area of Research. Syllabus should be prescribed by the Supervisor in Consultation with the Doctoral Committee
 - (c) The syllabus for the course work is 5 units (for the Paper III &Paper IV) should be prepared and be submitted at the end of the first Doctoral Committee Meeting. Hence the Supervisor is requested to prepare the draft Syllabus and discuss in the First Doctoral Committee Meeting. Please cooperate
- (3) They should complete the Course work (before January 2023)
- (4) The Doctoral Committee meeting should be conducted periodically once in 6 months after the Completion of Course work. (January and July), irrespective of the date of Joining. No intimation will be sent from the University.
- (5) The first Doctoral Committee meeting should be conducted on or before 30.09.2022 and the date of the Doctoral Committee meeting should be informed 10 days in advance to our office in future.
- (6) The Doctoral Committee is requested to insist the Research Scholars to publish their Research Papers only in Journals with SCOPUS Rating and with the name of our University as Dr. M.G.R Educational and Research Institute, Chennai - 95, the Scholar as first author. Papers without this will not be accepted. The Doctoral Committee should point out at least 5 Journals which are in SCOPUS for Publication.
- (7) The receipt for the payment of Semester fees upto the current Semester and the progress Report for the previous 6 months should be submitted before each Doctoral Committee meeting. The Course Work Examination fees (Rs.1500/-) should be paid before the first Doctoral Committee Meeting and receipt should be submitted to the office of the Dean (Research).
