I am to inform you that the Research Advisory Committee has been constituted with you as a Convener / Member for the candidate Mrs. M. Mohideen Banu, [Enroll. No. 22149100001/FT] who has registered for doing Ph.D. Degree in the subject **Education on Full** Time basis under the supervision of **Dr. M. Manivannan**, Professor & Director, School of Education, Tamil Nadu Open University, Chennai.

The detailed functions of the Research Advisory Committee are given as overleaf (Annexure I). Some of the salient features are given below:

- To discuss advice and recommend on all matters connected with the candidate's research from provisional registration to till the submission of thesis.
- 2. To suggest courses to be undertaken by the candidate during the first year of the provisional registration and to examine the candidate by written and oral examinations, on the completion of such courses, at the end of the first year of provisional registration and to forward a report to the Research Section on the fitness or otherwise of the candidate to proceed with his/her research, recommending the confirmation of the provisional registration.
- To monitor the student's research work by directing him/her to submit half-yearly reports and it should be maintained in the prescribed form and kept by the supervisor in the School.
- 4. To conduct and supervise the presentation of the final draft of the candidate's proposed thesis for approval before the submission of the synopsis of the thesis to the University and to give a certificate to this effect to be submitted along with the synopsis.
