This has reference to your proposal which has been submitted by your institution to start B.Sc.,(N) programme for the academic year 2021-2022. Your institution was inspected on 27.07.2021 After going through the report, comments of the inspectors, documents and compliance report submitted by the institution (vide. Ref.No: 3 to 6), we are herewith communicating a copy of the resolution of the Council passed at its meeting held on 14.09.2021 for information and necessary action.

Extract of the resolution of the Council

The Tamil Nadu Nurses and Midwives Council having noted the clearance given by the Tamil Nadu Government for starting a College of Nursing for degree programme in B.Sc., Nursing programme at **Vel Nursing College Periyapalayam Road, Velan Nagar, Majankaranai Village, Uthukottai Taluk, Thiruvallur District under Vels Institute of Science Technology & Advanced Studies (VISTAS) Deemed to be University, Chennai** and having satisfied itself with the infrastructure available in the institution as pointed out in the Primary/Statutory inspection report and in exercise of the powers vested with the Council under rule 37 of the rules made under Section 11(2) (c) of the Tamil Nadu Nurses and Midwives Act (Act III) 1926 resolves to grant Provisional Recognition to the above said institution to conduct the first year B.Sc., Nursing Programme for the academic year 2021-2022 only **with an annual intake of not exceeding 100 Students** based on the Parent Hospital **“Vels Medical College & Hospital, Tiruvallur”** shown by **the institution as well as Clinical Establishment Registration Certificate issued for “Vels Medical College & Hospital, Tiruvallur with 330 beds** subject to the following conditions:

1. Do not admit underage & overage students.
2. Admission of candidates should not exceed the number indicated in Tamil Nadu Nurses and Midwives Council Order for the year 2021-2022 and admission must be made only once a year.
3. Fresh batch of admission of students is permitted for 2021-2022 only.
4. Every year list of candidates admitted during the year together with their age and qualification to be uploaded **in the Council’s Institutional Management Software (I.M.S.)** for the purpose of registration. Also should come to the Council for certificate verification as and when informed by this Council.
5. The institution should not charge any capitation fee or donation for admission of candidates except the regular tuition and special fees as laid down in the prospectus/regulations.

6. **Copy of the Pollution control board certificate (Bio-Medical Waste) with number of beds (330 beds) for Vels Medical College& Hospital, Tiruvallur need to be submitted within three months from the date of receipt of this communication.**
7. Failure to maintain the prescribed requirements will result in de- recognition.
8. Inspection will be arranged by this Council before starting II-batch of programme in 2022-2023 under Rule (38) of the rules framed under section 11 (2) (c) of the Tamil Nadu Nurses and Midwives Act III of 1926 **and students should be admitted for II year after obtaining orders from the Council only.**
9. The institution shall have to abide by the guidelines/instructions/regulations issued by Tamil Nadu Nurses and Midwives Council, State Government/Indian Nursing Council, New Delhi from time to time.
10. The institution shall have to abide by the guidelines/instructions/regulations issued by Indian Nursing Council, New Delhi with regard to availability of Teaching faculty, Clinical and Physical Facilities, Infrastructural facilities in conformity with Regulations framed under the provisions of Indian Nursing Council Act 1947.
11. **Annual Programme fee of Rs.10,000/-must be paid by 30th June every year through online mode in Council website under the link “INSTITUTION MANAGEMENT SYSTEM (IMS)”.**
12. **Council Prescribed Uniform should be adoned by the students and it should be strictly adhered.(Copy enclosed)**
13. All the correspondence should be done by the Principal only.
